Membership Restrictions for World Championships Tryouts [Doug Smith / Will Covert]

We would like to add a sentence clarifying that any accidental lapse of membership of thirty days or less is not a disqualification from the tryouts. We have reviewed the past membership-related disqualifications and found this change consistent

with the way the membership requirements have been enforced. We also feel this language keeps the spirit of the membership requirements without being overly strict.

The Board supports this clarification.

Our Mission

- Support the use and health of the Icelandic Horse according to international standards.
- Advance the study, breeding, and exhibition of the Icelandic Horse.
- Represent FEIF in the United States and represent the United States to FEIF.
- Maintain a registry of purebred Icelandic Horses.

The USIHC mission statement is at the top of this page because THAT is our guiding standard.

Keeping in mind our mission statement, Congress will set aside a sum of money (15% of ----??, as of January 1) to be used for funding events and projects. This amount is not REQUIRED to be spent during the calendar year.

What constitutes an “event”? -- CREATIVE PROJECTS WITH IMPACT that meet our mission statement; such as evaluations, shows, seminars, clinics, lectures...

Congress has funded a number of events which were determined to be high impact and uphold our mission statement. A few examples are the first Breed Evaluations held in Oklahoma, the Gaits & Conformation Clinic, the Young Horse/Foal Tour, and Equine Affair. Each of these began as an idea, and were developed into an event by interested and active members.

Members are encouraged to submit proposals requesting funding for their event or project. This proposal must be made at least 8 weeks before the event in order to allow time for proper consideration by the board. A specific dollar amount should be included.

The proposal must address the Congress mission statement and provide the following:

- how does the request meet the Congress mission statement?

USIHC FUNDING DISCUSSION

- how does this activity advance the Icelandic horse's presence in the U.S. or how is it likely to increase membership in the USIHC?
- who does it serve, i.e., current members? potential members? general public?
- how many will benefit/be reached?

The funds would be reserved upon receipt and acceptance of the proposal and would be disbursed upon successful completion of the event. The event organizer is required to submit a brief report after the event to summarize how goals and the mission statement were met and provide feedback, such as:

- did the event attendance match the prediction?
- did the event achieve the goals in the original application?
- what could be done differently to achieve better results in the future?

Creative and original thinking by members will be rewarded with funding. Those who DO shall receive. It is the responsibility of the membership to come up with interesting ideas that suit their needs and present these ideas to the board. It is not the responsibility of board members to think up events and activities for the membership.

Numerous committees exist as an alternate way to fund an event by brainstorming with others with similar interests, developing a project and bringing it to fruition.

Due to the diversity of our membership and the interests and needs across the country, we have determined that it is not possible to assign a uniform dollar amount for an event. Rather, we will use the follow up reports to help the board track funding and events, and provide some feedback for adjustments and improvements over time.

RE: 2012 Regional Club Matching Fund Request

The Frida Icelandic Riding Club (FIRC) is again sponsoring a USIHC sanctioned show in May of 2013. To get the publicity underway, we have already advertised in both TOLT NEWS and THE ICELANDIC QUARTERLY. To get the attention of the general public and owners/riders of non- Icelandic horses, we will be posting flyers, hand bills and posters in the near future at tack shops in Maryland, Virginia, West Virginia and Pennsylvania. We will also be a presence at the two upcoming Horse Expos that will include a booth, breed demo and stall at the Pennsylvania Horse Expo and a various demonstrations throughout the local area where the FIRC drill team routinely appears. Several large private barns have also agreed to display our promotional material. Additionally, retailers, such as Tractor Supply, Tri County Feed and Southern States, will post our information as often as we give it to them as will Frying Pan Farm Park (the venue for the show and a public facility).

Before undertaking this project I outlined our effort to Martina Gates, USIHC Regional Club Chairperson, and received her verbal approval for the project.

To date, I have spent \$285.94 on promotional material that includes handbills, flyers and posters on foam core. Please reimburse the Frida Icelandic Riding Club in the amount of \$142.97 under the provisions of the USIHC matching funds program.



Contract For Exhibit Space

In consideration of the rental sum of \$350 and the agreements herein contained, Equestrian Promotions, Inc. hereby grants to FRIDA Icelandic Riding Club whose address is 8700 Rosaryville Road, Upper Marlboro, MD, 20772-, telephone (301) 442-8344, hereinafter referred to as the "exhibitor", the right of renting during the exhibition at Harrisburg, Pennsylvania on February 21-24, 2013 space number(s) 17 on the official floor plan which consists of 20 ft on the aisle and 10 ft deep. This space is to be used to exhibit the following products: promotion of the Icelandic horse, and is subject to the following conditions.

The Exhibitor agrees to pay 60% of the sum above specified by October 30, 2012, and the balance by December 30, 2012. The signed and completed Rental Contract for Exhibit Space shall be returned to Equestrian Promotions, Inc. no later than November 21, 2012 or 10 days after receipt of the contract, for those sent to the Exhibitor after November 21, 2012.

There will be no exclusives granted to any exhibitor.

Exhibits must not be dismantled or removed before 5 pm on Sunday.

Exhibitors are responsible for the complete removal of their exhibits, and for clean up of their exhibit space immediately after the show.

The conditions, rules and regulations printed herein are made a part hereof and incorporated herein and the exhibitor agrees to be bound by each and every one of them, and Equestrian Promotions, Inc. shall have full powers of interpretation, amendment and enforcement of all said conditions, rules and regulations.

Equestrian Promotions, Inc. will not be liable for refunds or any other liabilities whatsoever for the failure to fulfill this contract due to any of the following causes:

- (a) By reason of the enclosure in which the exhibition is to be produced being, before or during exhibition, destroyed by fire or other casualty
- (b) By an act of God, public enemy or strikes, terrorist related activities, the requirement of statutes, ordinances or any legal authority, or any cause beyond the control of Equestrian Promotions, Inc.

This rental contract constitutes the entire contract between Equestrian Promotions, Inc. and the Exhibitor and no modification shall be valid unless written upon or attached hereto and same are approved in writing by an officer of Equestrian Promotions, Inc.

Booth Attendants/Activities: No unattended exhibits are permitted. Exhibitors are required to have competent personnel in charge of their exhibit throughout the show; exceptions must be authorized by Equestrian Promotions, Inc. in writing. All exhibit activities must be confined to the exhibitor's booth space. Solicitation of other exhibitors during show set-up, show hours and show tear-down is prohibited.

Disputes: Disputes arising from any cause whatsoever, among exhibitors, shall be settled by Equestrian Promotions, Inc., whose decision shall be final. Show management further reserves the right to discontinue any exhibit which may be conducted in violation of the conditions, rules and regulations governing the show. There will be no refund of rental space.

Insurance and Liability: General liability and property insurance must be obtained by the exhibitor at the exhibitor's expense. All exhibitors are required to provide a Certificate of Liability Insurance naming Equestrian Promotions, Inc as an additional insured. This Certificate must be forwarded to Equestrian Promotions, Inc. at least 30 days prior to the event. A new certificate is required each year. NO exhibitor will be allowed to set up a booth without this certificate, regardless of type of booth. No refunds will be given for a failure to comply with this policy. The company named on this contract must be the company named on the insurance certificate as the policyholder. Equestrian Promotions, Inc. assumes no risk, and by acceptance of this agreement, the exhibitor expressly releases Equestrian Promotions, Inc. of and from any and all liability for any damage, injury or loss to any person or goods which may arise from the rental and occupation of said space by exhibitor, and agrees to hold and save Equestrian Promotions, Inc. harmless of any and all loss or damage by reason thereof. Equestrian Promotions, Inc. assumes no responsibility whatsoever for any property placed in the exhibition building and Equestrian Promotions, Inc. is hereby released and discharged from any and all liability from any loss, injury or damage to persons or property that may be sustained while at the Pennsylvania Farm Show Complex.

1. Setting up of Exhibits: Booths will be set up and ready for spectators one (1) hour prior to the scheduled and announced opening time of the show. A change in the show hours may be made by Equestrian Promotions, Inc. for the benefit of the show.

2. Care of Exhibits: Exhibitors must not throw refuse on the floor, or use/misuse any other material that may endanger public safety or inconvenience other exhibitors.

3. Be a Good Neighbor: Exhibitors agree to abide by the Be a Good Neighbor Policy included in the Exhibitor Information Package.

4. Removal of Goods: Exhibitors will not be permitted to dismantle exhibits or do any packing prior to the official closing time of the show and then only after all spectators have left the exhibit building.

5. Tickets: General admission tickets will be sold at the box office at the entrances to the exhibition that shall entitle the holder to see all displays in the exhibit area.

5. Employee Passes: Employee passes will be issued upon receipt of written application from the exhibitor.
